# **ABOUT THE COMMUNITY**

With white, sandy beaches, turquoise waters and an iconic cultural scene, Miami Beach has a rich history stemming back to the turn of the 20th century, evolving over the years into a major convention destination and international resort area. With a population of 80,000 and an average daily population closer to 200,000, Miami Beach remains a destination for millions of visitors to its world-famous shores each year. Its evolution from a retirement community to a diverse, multi-cultural community where the average age is 40 reflects its transformation to a younger, higher income, working community.

Miami Beach is a cosmopolitan, tropical island city whose residents are as diverse as its visitors. The City boasts over seven miles of beaches and an <u>uninterrupted Beachwalk</u> from one end of the City to the other, a first-class convention center, roughly 21,000 hotel rooms, 2 public golf courses, 44 parks, 2 tennis centers, art and culture, dining and nightlife, world-class shopping, and even an ice rink, all within approximately 7 square miles. With single and multifamily housing stock and Class A office, the City is also committed to expanding housing inventory and preserving its historic buildings and culture.

As a trend-setting arts and entertainment mecca, and a shopping and cultural wonder situated between Biscayne Bay and the blue waters of the Atlantic Ocean, Miami Beach is enjoyed by visitors, world travelers, celebrities, the workforce and locals alike. The City is home to museums and art galleries, and numerous cultural organizations such as the New World Symphony and the Miami City Ballet. Walking the streets and esplanades of Miami Beach provides a world of artistic treasures. International art, boat and car shows, and wine and food festivals make their home here every year while corridors such as Lincoln Road, Española Way, Ocean Drive, and Collins Avenue provide a wide variety of boutiques, popular retailers and restaurants.

The city benefits from being part of a global transportation gateway with connections to world-class infrastructure, such as two nearby international airports, and PortMiami, known worldwide as the Cruise Capital of the World. Miami Beach is also a significant driver of foreign investment, which brings jobs, diversity and strong real estate values. Miami Beach is also seeing an influx of businesses, entrepreneurs and talent from New York, California, Chicago and other urban centers with strong technology and financial services hubs.

## **CITY GOVERNMENT**

Incorporated in 1915, the City of Miami Beach operates under a Commission/City Manager form of government. The City Commission consists of the Mayor and six Commissioners who serve as the policy-making body of the City. The Mayor and Commission are elected on a citywide, nonpartisan basis, and they appoint the City Manager, City Attorney, City Clerk, and Inspector General. All other department heads are appointed by the City Manager with the consent of the City Commission. The City Manager is responsible for implementing Commission policies and decisions, providing executive level leadership, vision, and guidance to the organization, and for the daily operations of the City.

The City of Miami Beach is a full-service government providing a broad range of services to its residents and annual visitors, from public safety and planning to housing and utilities. Its FY2024\_annual budget is \$829 million, with a General Fund operating budget of \$428 million. Miami Beach residents are highly engaged and connected with their local government, with over 40 separate boards and advisory committees providing input to departments and the elected body.

# **ABOUT THE DEPARTMENT**

The Economic Development Department is responsible for supporting the City's robust economy through strategies and initiatives that stimulate balanced growth. With a staff of 9 FTEs including the Director and a FY 2024 operating budget of \$2.35 million, the department strives to connect businesses, the community, people and jobs, business assistance and resources, corridor development/redevelopment, and real estate as it helps to create a diverse economy for Miami Beach's dynamic and resilient community.

#### **BUSINESS RETENTION AND ATTRACTION -**

Developing and leading economic development initiatives that support the retention and attraction of businesses through a variety of strategies. The Department provides business support services, resources and investments and conducts small business outreach and advocacy. Staff facilitate interactions between private property owners, and the City's various regulatory departments. In addition, staff provides data resources, market research and other information to businesses to support their retention and expansion goals. Marketing and branding efforts also promote the City of Miami Beach's attributes as a business destination.

**COMMUNITY REVITALIZATION** – Supports the City's resilient initiatives through holistically identifying strategies and projects that help grow Miami Beach's talent pool and businesses, promoting housing opportunity, and supporting the growth of the City's live-work-play environment. In addition, the Department encourages private investment and partnerships while fostering a positive cohesive relationship with the businesses, residents, and visitors.



The Economic Development Department also provides general oversight for redevelopment areas in Miami Beach, including the Miami Beach Redevelopment Agency (RDA) and the North Beach Community Redevelopment Agency (NBCRA). The Department also assists in overseeing the management agreement for the Miami Beach Convention Center campus to ensure it is aligned with the City's operational plan, as well as best practices for securing booking opportunities that produce significant hotel revenue, and financial and community benefits. In addition to the North Beach CRA Advisory Committee, the 41 Street Committee, and various business improvement districts, the Department serves as liaison to the Convention Center Advisory Board (CCAB) to promote alignment between the Miami Beach Convention Center operations and community and resident needs. The newly renovated, world-class venue represents a critical economic engine for the City and region supporting a wide range of small to large businesses through direct and indirect economic impact. The Department also provides administrative leadership for the management of the City's partnership with the Greater Miami Convention and Visitors Bureau with a focus on Convention Center sales and hotel bookings.

# THE POSITION

The Economic Development Director manages and oversees the professional administrative work planning, organizing, implementing, and directing the activities of the City's Economic Development Department. This highly visible, handson professional role is responsible for managing impactful business relationships and promoting effective initiatives to enhance the City's economic development efforts. Supervising a team of professionals, the Director works to facilitate equitable economic opportunity by building a diverse, vibrant economy; catalyzing job creation, private investment, and revenue generation; supporting existing businesses; promoting the attraction and creation of new businesses; and facilitating real estate and joint development and community redevelopment in the City of Miami Beach.

- Assist developers, corporations and investors in locating commercial space/sites, conducting tours and providing information.
- Create and implement marketing strategies and campaigns that appeal to business leaders and the workforce.
- Assist with contract administration and deliverables of agreements related to the management of the Miami Beach Convention Center and campus, and the City's partnership with the Greater Miami and Miami Beach Convention and Visitors Bureau.
- Provide oversight for the City's two community redevelopment agencies (Miami Beach Redevelopment Agency and North Beach Community Redevelopment Agency).
- Lead planning efforts for commercial corridors and redevelopment areas to promote economic growth, job creation, affordable and workforce housing opportunities, infrastructure and mobility.
- Evaluate, recommend and negotiate public-private partnerships and joint development project agreements which maximize use of City assets, further City priorities and goals, and are in the best interest of the City.

- Represent the City in the private sector and with the Miami Beach Chamber of Commerce, Miami-Dade Beacon Council, and other professional economic and business development organizations.

# COMPENSATION AND BENEFITS

The City of Miami Beach offers competitive total compensation that includes a comprehensive benefits package with medical, dental and vision insurance (eligible on 1st month after 30 days of full-time employment); health savings and flexible spending accounts; paid time off, wellness incentives; paid parental leave; voluntary contribution to 457 retirement plan; paid time off; and more. The City also has its own defined benefit pension plan with a 2.5% annual multiplier and 5-year vesting schedule. The plan offers a maximum benefit of up to 80% of your highest five-year average salary. The salary range for this position is \$144,100 - \$259,000 and the expected hiring range is\$170,000 - \$230,000, depending on qualifications.
