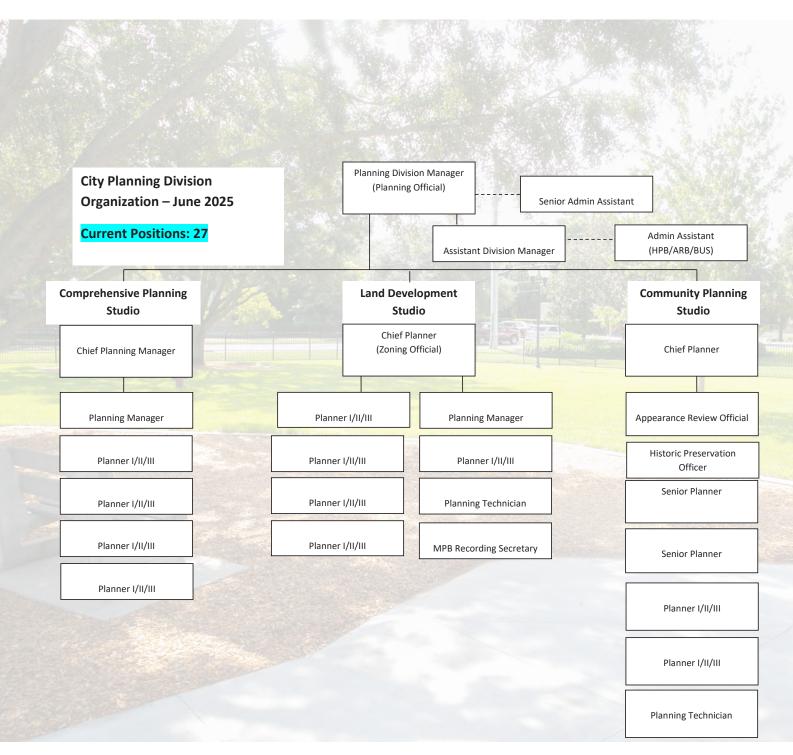

#### THE DIVISION

The Economic Development Department is comprised of five customer-service oriented divisions, including Permitting Services, Code Enforcement, City Planning, Business Development and the Downtown Development Board/Community Redevelopment Agency.

These divisions work as a unified team to facilitate development, aid business owners and companies looking to locate in Orlando, issue residential and commercial permits, collect business tax receipts and enforce city codes.

In short, Orlando sees itself not just as a growing city, but as a model for smart, inclusive, and tech-savvy urban development. It's blending traditional planning with cutting-edge innovation to shape a future-ready cityscape.





#### THE POSITION

This leadership role calls for a forward-thinking professional to guide a dynamic team of planning experts, ensuring the successful execution of the city's <u>newly updated Comprehensive Plan</u>, Land Development Code and strategic initiatives. The position plays a pivotal role in shaping a sustainable, inclusive, and vibrant future for the community.

The role oversees an operating budget of \$3.2 million and a team of 26 employees, including 5 direct reports. Direct reports include the following positions: Chief Planner (3), Assistant Division Manager and Administrative Assistant.

#### **DUTIES AND RESPONSIBILITIES**

- Supervision and Management: Oversee and supervise the Planning Division, Comprehensive Planning, Land Development and Community Planning Studios.
- Project Management: Manage complex planning projects, including research, analysis, and execution, ensuring they are completed within prescribed timeframes.
- Regulatory Oversight: Ensure consistent application of land development regulations, zoning ordinances, and the Comprehensive Plan.
- Policy Development: Recommend, establish, or revise ordinances, rules, regulations, and capital improvement schedules related to planning and city activities.
- Interdepartmental Coordination: Collaborate closely with managers and colleagues in various City departments, including Public Works,

Transportation and Housing.

- Stakeholder Engagement: Communicate effectively with the public, city staff, elected officials, the media, outside professionals, and community stakeholders on planning and development issues.
- Reporting and Presentations: Prepare reports and presentations for City Council, boards, committees, and other groups, clearly and concisely communicating planning information and recommendations.
- Long-Range Planning: Contribute to long-range plans, code amendments, and community engagement activities focused on future growth and development.
- Customer Service: Provide professional and extensive customer service, assisting applicants, owners, and the public through planning and application processes.

### REQUIRED QUALIFICATIONS

- Master's degree in urban and Regional Planning, Engineering, Architecture, Economics, Public Administration, or a related field is preferred.
- Ten or more years of professional planning experience, with at least six years in a supervisory capacity, are preferred.
- American Institute of Certified Planners (AICP), American Institute of Architects (AIA) or American Society of Landscape Architects (ASLA) certification(s) is required.
- Strong leadership, communication (oral and written), analytical, problem-solving, and interpersonal skills are essential.
- Valid Florida Driver's License \*or\* a valid license from another state for transfer within 30 days of employment.

#### **DESIRED SKILLS AND ABILITIES**

- Demonstrated expertise in reviewing development applications and interpreting planning regulations.
- Upholds integrity and transparency in all aspects of decision-making.
- Maintains composure and effectiveness under public scrutiny, political pressure, and while managing competing priorities.

- Comprehensive knowledge of applicable federal, state, and local laws, codes, and regulations, including Florida's Growth Management Laws.

- Coordinate across multiple city divisions and departments involved in economic development and planning to support a cohesive and sustainable community vision.
- Evaluate and streamline existing processes, identifying opportunities to improve efficiency and reduce duplication of efforts.
