WELCOME TO TAMARAC - THE CITY FOR YOUR LIFE!

Tamarac offers an exceptional blend of suburban comfort and vibrant community life. With a population around 74,000, the city maintains a safe atmosphere with violent crime 44% lower than the U.S. average making it appealing for families and retirees alike. Its affordable housing market with median home values hovering around \$317,000 (below national averages) with numerous single-family homes, condos, and townhomes offers solid entry points for buyers and investors. Nestled in northwest Broward County, Tamarac's strategic location gives residents easy access to Fort Lauderdale, Miami, the Everglades, and South Florida's renowned beaches via major highways like the Florida's Turnpike, I 595, and Sawgrass Expressway.



The city has year-round sunshine while making a lasting impact in a vibrant, growing community! Outdoor enthusiasts and families will find plenty to enjoy across 16 parks including a waterfront linear park, skate park, and dog park plus premier recreation centers with aquatic facilities, tennis, basketball, and an arts and crafts festival. The city hosts lively weekly farmers markets, multicultural events, robust public art, and community-driven fitness classes and sports leagues all supported by city-run shuttles and accessible amenities. This strong infrastructure fosters an active, engaged lifestyle that, when paired with Tamarac's diverse demographics and strong sense of belonging, makes it a truly wonderful place to call home.

Total city budget is \$294 million, and citywide workforce is 467 FTE.

CITY GOVERNMENT

The City of Tamarac operates under a Commission-Manager form of government. The five-member City Commission consists of four Commissioners, each elected by district, and a Mayor elected at large.

The Commission is responsible for setting policy, adopting the annual budget, establishing community goals and objectives and making decisions that shape the quality of life in the community. The City Commission appoints a City Manager who oversees the daily operations of the City, while at the same time carrying out the Commission initiatives and directives. A City Attorney has also been appointed to manage the City's legal affairs.

THE DEPARTMENT

The Public Services Department is dedicated to maintaining and enhancing the city's essential infrastructure, utilities, and environmental systems. Divisions ensure safe, sustainable, and efficient services for residents and businesses and include:

ENGINEERING

Manages design, review, and inspection of public infrastructure projects such as roads, sidewalks, sewer systems, traffic calming devices (e.g., speed humps), and utility coordination.

CAPITAL IMPROVEMENT PROJECTS (CIP)

Oversees planning and delivery of major infrastructure and facilities upgrades.

WATER SERVICES

Ensures the purification and safe delivery of potable water.

SOLID WASTE / RECYCLING

Supports compliance with Florida's waste management requirements.


STORMWATER (CANAL/LAKE)

Maintains the city's canals and lakes: controlling aquatic vegetation, clearing debris, inspecting and repairing drainage structures, and implementing minor infrastructure improvements.

STREETS & SIGNS

Maintains and repairs city-owned streets, sidewalks, guardrails, and streetlights, including rapid response for pothole repairs.

THE POSITION

The Director of Public Services is a senior leadership role responsible for planning, directing, and managing the City's Public Services Department, which includes 11 divisions such as public works, utilities, stormwater, engineering, grounds maintenance, and capital improvement plan projects. This position ensures efficient service delivery, regulatory compliance, and infrastructure development to meet the needs of a growing population.

The position reports directly to the City Manager and is responsible for overseeing a departmental budget of \$69.5 million. The department includes 146 employees, with six direct reports: the Assistant Director of Public Works, Assistant Director of Utilities, Capital Projects Manager, City Engineer, Operations Manager, and Senior Administrative Assistant.

RESPONSIBILITIES

- Oversee design, construction, maintenance, and operations of city infrastructure, utilities, and facilities.
- Manage the City's Capital Improvement Program and departmental budgets.
- Direct engineering functions, including traffic systems, GIS, and asset management.
- Coordinate with local, state, and federal agencies for compliance and funding.
- Lead strategic planning for public works and utilities.
- Respond to emergencies and ensure operational continuity during disasters.

MINIMUM QUALIFICATIONS

- Bachelor's degree in civil or environmental engineering.
- 10 years of progressively responsible experience in public works/services, including 5 years in management and 3 years in senior administration.
- Florida Professional Engineer (PE) license.
- Valid Florida Driver License.
- NIMS certification (sponsored by the City).
