First established at the turn of the century by the railroad industry, this convenient transportation hub is served by three major rail lines, and three state highways. As a community, it has a reputation for flexibility and adaptability looking to innovation to provide government service. West Chicago offers excellent schools, a growing business park and convenient access to parks, shopping and restaurants. It is located 35 miles from the City of Chicago.

The City offers a full array of municipal services and operates under a Mayor-Council form of government. The Chief Building Official is appointed by the City Administrator and reports directly to the Community Development Director. The community has a long history of political stability and prides itself on a progressive, professional staff. The former Chief Building Official served the City for 18 years.

The City is seeking an organized, approachable, and fair professional to be the next Chief Building Official for the City of West Chicago. The ability to oversee and effectively manage multiple professional service contracts at one time is essential. The City is also particularly interested in candidates that have a mature customercentric approach to applying City codes.

THE POSITION IN BRIEF

The Chief Building Official serves as a member of the City's Community Development Department. The current annual budget for the Community Development Department is \$1,100,000. The Chief Building Official oversees one full-time Administrative Assistant and provides daily oversight of several city consultants that provide various development related services.

The Chief Building Official oversees contractual services that include plan reviews, code enforcement, and inspection services. This oversight includes residential, commercial, and industrial development and construction related services. The Chief Building Official serves as the City's representative to these various services for the City residents, City businesses, and developers working in the City.



OPPORTUNITIES

Residential Growth: The City is currently undergoing significant growth. This includes a planned 266-unit single family residential subdivision that is scheduled to begin in the fall of 2022.

Contract/Agreement Renewals: The next Chief Building Official will be tasked with issuing and reviewing a request for proposals related to the various outsourced building related services.

Local Building Code Update: The next Chief Building Official will also have the opportunity to update the Local Building Code from the currently adopted 2015 ICC Code to the 2021 ICC Code.

POSITION REQUIREMENTS

- A Bachelor's Degree from an accredited university in construction management, project management, or a related field. A
 Master Code Professional Certification is desirable, but not required.
- A minimum of 5 years of experience with building review and code compliance. Seven years of experience with some supervision experience is preferred.
- Experience in contract management is a must.
